### **BURIAL CHARGES**

**Fees, payments and sums fixed and settled under the Local Authorities Cemeteries Order 1971 No.204 Para. 15.**

#### **PART 1 – FOR THE INTERMENT IN ANY GRAVE**

Of the body of a still-born Child whose age at the time of death exceeds 24 weeks, includes Grave and associated Memorial Part 3 costs. **FREE**

Of the body of a person whose age at the time of death is below the age of 18 years, includes Grave and associated Memorial Part 3 costs. **FREE**

Of the body of a person whose age at the time of death is 18 years or above. **£105.00**

For the interment of cremated remains in a grave in respect of which an Exclusive Right of Burial has been granted. **£85.00**

#### **PART 2 – EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES**

For the exclusive right of burial in an earthen grave  
2.5 metres x 1.2 metres x 1.85 metres deep in  
SE, SW & NW Sections **£260.00**

For the exclusive right of burial in an earthen grave  
2.5 metres x 1.2 metres x 2.3 metres (double plot)  
SE, SW & NW Sections **£420.00**

For the exclusive right of burial in an earthen grave  
3 metres x 1.35 metres x 1.2 metres deep with Memorial Beam **£260.00**

For the exclusive right of burial in a double width earthen grave  
3 metres x 2.7 metres x 1.2 metres deep with Memorial Beam **£420.00**

Of cremated remains in an earthen grave  
1 metres x 0.6 metres x 0.5 m deep in NW Section **£105.00**

Of cremated remains in an earthen grave  
1.1 metres x 0.93 metres x 0.5 m deep with Memorial Beam **£105.00**

A nominal £10 administration fee will apply for the transfer of Grant of Exclusive Right of Burial.

Anyone who cannot prove an immediate family connection (i.e son, daughter, father, mother) and have lived in the Parish would be required to pay double the rates indicated.

The Fees indicated for the various heads of Part 2 include the Deed of Grant and all the expenses thereof

### **PART 3 – MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS.**

For the right to erect or place on a grave in respect of which exclusive right of burial has been granted.

#### **A FLAT STONE**

##### ***Burial***

Not exceeding 1 metre x 1 metre in length / width or equivalent area **£105.00**

##### ***Cremation***

Not exceeding 0.4m x 0.4m or equivalent area **£105.00**

#### **A HEADSTONE**

Not exceeding 1.5 metres in height **£105.00**

Replacement of Headstone **£55.00**

**A VASE (*Glass not allowed*)** **£55.00**

**A TABLET ON A GRAVE** **£55.00**

#### **ANY OTHER MONUMENT FOR CREMATED REMAINS**

Not exceeding 0.6 m in height and occupying a space not exceeding 0.4 m x 0.4 m or equivalent area **£55.00**

#### **EXCLUSIONS:**

Kerb sets/Border stones are prohibited in all sections of the cemetery

#### **Note:**

#### **ADDITIONAL INSCRIPTIONS**

The fees indicated for the various heads of this part include the first inscription.

For each inscription after the first a further fee is payable **£55.00**

The placing of glass containers is prohibited.

The Parish Council reserves the right to look at applications for Monuments not covered by the above and to make decisions in individual cases.

All Memorials to be mounted onto a Memorial Beam must include a 100mm Plinth to accommodate any integral Flower Vases

These fees and charges were fixed by Resolution of the Parish Council on 18 January 2021 and apply from the 1<sup>st</sup> April 2021.
