- A; Progress report; PH will replace the Dog Fouling signs on the village hall site. AN to see dog warden from SKDC, with regards to putting official notices on the village hall site.
- B; Official letter sent to Parochial Church Council by JS, inviting a member to join the SWWVHC. As of the meeting on the 30th September 2019, there had been no reply.
- C; AN confirmed, we the committee, can have space on APC website, Someone on the committee to set up a page with Denise Gascoyne, so that any meeting minutes from SWWVHC can be posted. AN to forward the cut off dates for the Around Ancaster publications, so events on village hall site can be posted.
- D; JC to do an edited version of the meeting notes to go onto the APC website, and a short summary (newsletter) to be added to the Around Ancaster magazine.

F; Lloyds Bank, the balance is now available, SWWVHC has £2116 in the bank to date.

3, Progress and Reports; PH has made 2 new Dog Fouling signs, AN progress from APC, 4 of the 5 actions requested by SWWVHC put to APC have been approved, Access to website, Access to Around Ancaster, Notice board location change, Phonebox to be used as an emergency first aid station, have all been approved. There will be no reinstatement of grass cutting on the village hall site.

JS showed letter intended for Charity Commission, to change area of benefit, to be approved by members before sending, letter to be placed in files, all areas in brackets to be removed from letter before sending. The residents of Ancaster to have their say on the removal of Ancaster in area of benefit, hearing in November APC meeting, notice to be placed in Around Ancaster parish Magazine, giving people ²/₃ weeks notice on the meeting.

Already touched on the subject earlier in the meeting, with relocation of parish notice board, grass cutting allocation, website, Around Ancaster magazine, phone box as first aid station, AN spoke with Denise Gascoyne and Carol Bradford from APC, the use of APC annex has been offered as a venue for meetings of SWWVHC, rather than use Carlton Scroop Village Hall, a vote was taken by all present committee members present, and it has been decided to stay at Carlton Scroop for the foreseeable future.
